Dear Sheffield Household:

I am writing to advise you that the Town will continue the process begun last year of billing all households for use of the Transfer Station for Fiscal Year 2011, July 1, 2010 through June 30, 2011. As in past years, you have the choice of using the Transfer Station or legally disposing of your trash in another manner.

If you choose to use the Transfer Station for disposal of your trash and recyclable materials, the fee is \$185 for the year. The annual fee is \$130 for those senior residents who meet the following conditions:

- a. Born prior to July 1, 1940
- b. Must be the taxpayer of the household
- c. Must be owner's primary residence

Stickers may be obtained by completing and mailing (or bringing) the form below to the Tax Collector's office at the Town Hall, together with a check payable to the "Town of Sheffield" in the amount noted on the form. If a household wishes to purchase an additional sticker for a second household vehicle, the cost of this second sticker is \$10. No more than two stickers are allowed per household. Your sticker(s) is for your household only. Please include a self-addressed, stamped envelope for us to use when mailing the sticker back to you.

If you choose **not** to use the Transfer Station, you must let us know how you will be disposing of your trash and recyclables. Please check the appropriate response on the form below and mail to the Tax Collector as noted below. If we do not receive this form, you will be liable for the full amount of the fee.

Stickers must be adhered to the household vehicle transporting waste/recyclables. Loose stickers will not be accepted. If the sticker is not affixed with the adhesive backing to the vehicle, you will be denied access to the Transfer Station. You must obtain your sticker by **August 16, 2010**. Any vehicle not displaying a Maroon 2010-11 sticker **will** be denied access to the Transfer Station after this date.
