Chairman Ward called the Conservation Commission meeting to order at 7:07 pm.

- 1. Public Hearing on Notice of Intent (NOI) filed by The Nature Conservancy for property located on Kelsey Road, in accordance with the provision of M.G. L. C. 131, Sec. 40. The proposed project: ongoing ecological restoration and habitat management. There was not a representative for the Nature Conservancy tonight. Members of the public asked questions which were answered by the Commission. D. Ward reported that there are several different parcels that are being referred to. R. Wood made copies and shared the letter from the Massachusetts Division of Fisheries and Wildlife. R. Wood made a motion to approve the NOI with the condition of Notification to Chief Ullrich two days prior to any plan of burning and to go through the regular burn permit. T. Pitman seconded the motion. Motion carried, 4-0.

 R. Wood made a motion to close the public hearing. D. Ward seconded the motion. Motion carried, 4-0.
- 2. Public Hearing on Notice of Intent (NOI) filed by Tim Fulco for property located at Berkshire School, 245 S. Undermountain, in accordance with the Provision of M.G.L. C. 131, § 40. The applicant, Tim Fulco of Berkshire School, was present with Jackson Alberti of ForeSight Land Services. J. Alberti shared and reviewed the site plan with the Commission. He mentioned all work would be completed between the two bridges on the plan. This includes removal of a Gazebo and replacing it with a natural stone seating area. R. Wood made a motion to approve the Notice of Intent with normal conditions for Berkshire School at 245 S. Undermountain Road. A. Batacchi seconded the motion. Motion carried, 4-0. R. Ward made a motion to close the public hearing, seconded by T. Pitman. Motion carried, 4-0.
