Public Hearing: Request for Determination of Applicability filed by Martha Jackson for property on 400 Bow Wow Road. The proposed project is to install a rock retaining wall from end of the gabion boxes to edge of property line.

Joe Wilkinson from Wilkinson Excavating was present for the applicant. The Commission conducted a site visit prior to the meeting. Mr. Wilkinson explained that there is an existing retaining wall and that the property slopes down from the house. They will be adding rocks to the existing retaining wall and will extend it to the property line. They will put top soil down for the lawn after the wall is completed. All of the work is in the Buffer Zone, which is currently lawn area. No work will take place beyond the retaining wall and fabric will be placed behind the rocks. A site map was reviewed by the Commission and a discussion ensued. I. Collingwood motioned, with a second from T. Pitman to issue a Negative Determination #3 with the following condition: (1) Add erosion controls on North and West side of proposed work. The motion passed 5-0.

Approval of Minutes: The Commission reviewed draft minutes from September 11, 2017. A. Batacchi, Jr. motioned, with a second from T. Pitman to approve the September 11, 2017 minutes as written. The motion passed 4-0. J. Collingwood did not vote.

Proposed Donation to Housatonic Valley Association: Chairman Ward talked about joining the Housatonic Valley Association. A discussion ensued. <u>D. Ward motioned, with a second from C. Blackburn to join the Housatonic Valley Association and make a contribution of \$250.00, if the Town is not already a member. The motion passed 5-0.</u>

Bills Pending: The Commission approved a bill for the Berkshire Record.

Review of Forest Cutting Plans: There were no Forest Cutting Plans to review.

Upcoming Conferences and Mail: There are no upcoming conferences and no mail to review.
