Chairman Oleen called the meeting to order at 7:00 p.m.

Discussion/ Possible Action Regarding Proposed Dark Sky Bylaw.

K. Smith stated that he had been in touch with Robert Kilmer the Chairman of the Select Board and that this matter was to be discussed during their upcoming meeting. S. Hoy stated that she intended to be present for that meeting and would update the Board on what was discussed at the next meeting. K. Smith informed the Board that he had taken all of Town Counsel's comments and adopted them into the newest version of the Dark Sky Bylaw to be a zoning bylaw.

R. Cooper stated that he had gone out to East Rd. in Sheffield to view the properties that were discussed during the May 24, 2023 meeting and stated to the Board that he was surprised by how close the houses were to each other and that the Board owed it to the public to try and remedy the problem of excessive light displays. A discussion about the best method to limit the intensity and duration of light displays ensued. S. Hoy stated that she thought it would wise to draft the Dark Sky Bylaw as a General Bylaw because that has more teeth when it comes to enforcement concerns. Chairman Oleen stated that there was no reason that the Board could not write the bylaw as a General Bylaw regardless of the fact that they usually draft Zoning Bylaws.

ANR Requests.

M. Parsons presented the ANR request on behalf of John E. Trierweiler & John M. Trierweiler regarding the subdivision of 2.317 Acres on the westerly side of County Road. M. Parsons explained that this is a situation in which a son is buying parcels from his father. The Board determined that the land meets the frontage and setback requirements pursuant to the Town of Sheffield Zoning Bylaws.

K. Smith made a motion to approve the ANR as presented, seconded by S. Hov. The motion passed unanimously.

Discussion/Possible Action Regarding Mobile Food Establishments.

K. Smith stated that based on the memo that the Board received from Rhonda LaBombard, the Town Administrator, it was his understanding that the Select Board was unsure as to which Board was responsible to flush out the details about where, when and how the Mobile Food Establishments were to operate. It was the Planning Board's desire to avoid having to create a comprehensive guide on this matter, and to just make the Mobile Food Establishments permissible under the Zoning Bylaws, and that either the Select Board of the Board of Health would be responsible for working out the details.
