Continued Public Hearing: Special Permit application of R&R Ventures LLC, for property located at 700 S. Main St., Sheffield, for a Marijuana Micro-Business, per Section 3.1.3.H. Adult Use Marijuana Establishment of the Sheffield Zoning By-Laws. The property is in the Commercial District, Tax Map No. 20, Block 2 & Lot 17, Book 363 & Page 492. Chairman Collingwood briefly reminded the Board of last meetings discussion. He also stated for the record that this is the first Special Permit Application for a marijuana establishment to come before the Board under the Marijuana Bylaw. K. Smith stated for the record that he met with Robert Cohen after the last meeting to briefly to go over what the addendum ending up being. K. Smith continued that he is willing to go over the requirements with applicants coming before the Planning Board.
