Discussion of 5G Installation Bylaw Change - No updates from Town Counsel.

Discussion on a revised Site Plan from SK Design Group, Inc, with the Hewins Street Photovoltaic (Solar) Project – Navisun, LLC is the new holder of the Special Permit. Navisun, LLC would like to construct a tracker system as opposed to the conventional stationary system. The panels automatically follow the sun through the day. The overall footprint will be nearly identical to the approved plan. No additional clearing. The solar panels are controlled by small, silent electric motors that run off the array. These systems are more efficient than their stationary counterparts. A citizen asked how much more efficient is it? There is a 15% more output on this system stated S. Campbell. The capacity goes down but more kilowatt hours are produced. Hopefully the project would be complete by the end of August 2021.

## G. Oleen made a motion to accept the plan as presented. D. Martin seconded the motion. Motion carried 4-0.
