Currently there is no Zoning Bylaw for cannabis cultivation in the Rural District. A discussion ensued about creating a bylaw for outdoor cultivation.

Discussion on Zoning Bylaws: It was the consensus of the Board to look at the Table of Use Regulations at their July 11th meeting. They would also like to ask Town Counsel if there are other towns that have bylaws for cultivation already in place or are in the process of working on.

The Board had a discussion about creating an Overlay District in the village center and is waiting to hear back from Town Counsel.
