- 2. Updates with Lauren Hyde regarding marijuana bylaw change. L. Hyde shared Article 1 and Article 2 of the proposed amendment to the Zoning By-laws. Anything less than the 5,444 square feet is small scale solar, no matter where or how it is mounted.
- **6. Planning Board Rules & Regulations versus Special Permit Application:** Vice-Chair Marsden noted that she and R. Cooper had a chance to meet to go over the rules and application. C. McNeill reported there are three (3) totally different documents from different times with different wording. The project will take longer than expected. R. Cooper and C.
