Chairman Collingwood called the meeting to order at 7:00 p.m.

Public Hearing: Special Permit Amendment for Park Avenue Solar Solutions located on Clayton Road, to clarify that the screening referenced in Condition #2 of the Special Permit refers to the 'northwest' portion of the property and there be an explicit reference to the site plan dated as revised January 23, 2018 as well as the site plan approved and (b) clarification that the Special Permit also applies to single axis tilt tracking systems as well as fixed tilt. J. Collingwood opened the meeting by reading the hearing notice to the audience and the Board. He then introduced the applicant Kirt Mayland from Park Avenue Solar Solutions. Kirt made reference to the glare study that had been performed on October 1, 2018. A discussion ensued. After listening to Kirt's presentation and discussing the amendments that were to be made the Board decided to move forward with the amendment to the special permit. A discussion ensued.

D. Martin motioned, with a second from K.Smith to close the public hearing. The

motioned passed 5-0.

J. Collingwood stated the amendments that were discussed with the Board. The amendments will reference the January 26, 2018 site plan and application. The Board also added the right to install fixed or single axis trackers; either is approved within the original footprint. The screening will extend to the northwest corner of the property and wraparound 50 feet to the property located at 234 Clayton Road. The screening will stop 10 feet past the southeast border of the property located at 70 Pine Lane and remain in line with the end of the fence for the array. A discussion ensued regarding the amendments to the Special Permit. G.Oleen motioned, with a second from D.Smith Sr. to grant the Amendment to the Special Permit. The motion passed 5-0.

Discussion on Recreational Marijuana: Board discussed Recreational Marijuana under Zoning Bylaws.

Discussion on Zoning Bylaws: K. Smith described some revisions to the draft of Adult Use of Recreational Marijuana Bylaw that had been worked on by he and Rene Wood since the last meeting. K. Smith thanked Rene Wood for her time and assistance with the writing of this draft Bylaw. K. Smith explained that he believes the draft Bylaw considers grower, landowners, and the residents of Sheffield. A discussion ensued.
