* License is required for participation in Sheffield’s Farmers’ Market irrespective of other town’s valid license.

▪ Annual Fee for any license or permit not listed is \$50, plus application fee, except for Funeral Director, which is \$150 & expires April 30th with application due by March 30th. ▪ ANNUAL LICENSES expire on December 31st of the calendar year and must be renewed prior to January 1st or they are considered expired, unless otherwise noted.

▪ A RECREATIONAL CAMP PERMIT application, along with an original Health Care Consultant Agreement, must be received by May 1st of any year or the permit may be denied. ▪ LATE FEE: In addition to other fines and penalties, which may be imposed for conducting business without the required license/permit, a license/permit not renewed on time will be considered a new license/permit and will require an application. ▪ The APPLICATION FEE for a new license or permit \$25 or under is \$35; for a new license/permit over \$25, it is \$68. The application fee is waived for the initial application for license/permit once during the life of a business.
